

# The Grand Fortune Windfall

### Sponsored by Grand Casino Mille Lacs and Hinckley Official Promotion Rules NO PURCHASE OF ANY KIND IS NECESSARY TO ENTER OR WIN

**Promotion Summary:** The Grand Fortune Windfall promotion is an online promotion that begins on Monday, July 24, 2023, at 12:01am and concludes on Monday, September 30, 2024, immediately following the final drawing (the "Promotion Period"). Participants will win digital drawing entries by playing online games at <u>http://grandfortunewindfall.com</u> for a chance to win a share of \$112,000 in cash prizes in weekly and quarterly virtual drawings.

**Eligibility:** The Grand Fortune Windfall is an online promotion open to anyone of legal sweepstakes age in the participant's state and is free to play. **Persons in any of the following categories are NOT eligible to participate or win prizes in the promotion: Associates of Grand Casinos, any licensed MLCV associate; and Associates assigned to the Marketing Department, Director Level Associates and above and their immediate household**.
